 - Biggest challenge – sharing data with different municipalities

10:40 Governance Committee (Browne)

- Draft update to GAC Governance document – discussion and vote
 - Procedure for amending this document – 2/3rd majority to pass changes to the governance
- Jochen motioned to discuss, Mary Susan seconded
- Addition of a NYSAPLs representation has been added as an Ex-officio, one deputy NYS GIO, a vacancy in NYC or local government rep. Keeping the members at 23.
- Changes to chair and chair elect, previously this took place in the December and March meeting now a new chair would start in January and a new election would happen in the fall.

11:20 Standing Reports

- Geospatial Services Report (DeGironimo)
 - Since the March meeting, Geospatial Services turned 1!
 - Several new hires and currently hiring
 - Enterprise EA InProgress - finalizing implementation, 22 agencies are included in the agreement
 - Data Services update:
 - Orthoimagery - Down to 4 years old as the oldest imagery, 6 in and 12 in are being processed now
 - Elevation - we have some in progress from USGS and Champlain valley
 - Data improvement – building location and school layer improved
 - Parcels – working on a new release of parcels
 - SAM - 7,300 edits a week, testing new geocoders, proposal in with Esri to modernize the geocoder, enterprise address validation
 - NSGIC Update:
 - Lis visited Capitol Hill educating on GIS
 - Some discussion about the 988 suicide hotline and its relation to GIS
 - Open Data DC using AI - <https://opendata.dc.gov/pages/compass>

11:40 Continue Standing Reports

- NYSGISA report (Knauss)
 - Dawn McCall is updating their back-office to the cloud, planning to automate membership renewal
 - Increasing awareness of this being a volunteer organization
 - Sept 23rd Geospatial Summit in Skaneateles, NY
 - 2025 GeoCon in Lake Placid
 - Surveyors are excited to work with us and a joint legislative committee with NYSAPLS, they in particular are focused on parcels
- Federal report (Duncan)
 - NOAA Dan Martin – update of the national spatial reference system, expect a 2026 final release
 - Farm service agencies:
 - NAIP is part of the 2024 data collection. 1-meter resolution, less than 10% cloud cover
 - USGS – 3D national topography model, data collab for August 2024, and 3D hydrography is putting together a plan to replace the 9 national surface water mapping
 - NY Hudson D22 project is currently under review by USGS
 - NY Lake Ontario is currently under review
 - USDA 3DHP project with the Chesapeake watershed for the next budget cycle

- State Agency Advisory Group report (Croll)
 - Last meeting was in June
 - Open-source software was the main discussion. Mostly Esri, some PostGIS, QGIS
 - Beth Nolan (ITS) talked about ITS software
 - Watercraft inspection application – 15 partner organizations plus 200 boats to prevent invasive species. A spider analysis was presented to show all the boats coming to and from Sacandaga.
 - Jeff Langella presented LiDAR tools for building detection

1:00 NYS GIS Enterprise Architecture modernization (Nolan)

- GIS architecture modernization
 - Platform name is GeoHub
- Brief History
 - In 2015 one ArcGIS server hosted several map and geocoding services
 - 2017-2018 ShareGIS was built to support web service requests. More servers were added for elevation and orthoimagery
 - 2024 modernization project began with funding through the Cyber Risk Remediation Program
- Overview
 - Data warehouse – host for NY agencies. Share more data, storage, and data hosting
 - Publication for internal and external hosting options. Ability to collaborate and roll out to local governments.
 - Governance and versioning will ensure changes will have a limited impact.
- Scope in terms of personnel and dollars
 - 4.7 million dollars
 - 4 contractors - Those positions will perform knowledge transfer and hire 2 new ITS positions

1:15 Pathways to Certification for GIS Professionals (Albrecht)

- GIS Certification Institute (GISCI) and GIS Professional (GISP)
- Review of GISP
 - Late 1990s – GIS professionals figured out how to develop a certification to say we are indeed professionals
 - Originally the certification required a portfolio documenting GIS experience
 - In 2015 an exam was developed
 - 3-year certification, to recertify, you update your portfolio and ethics statement
 - Exam fee of \$250 and annual fee
 - Exam development committee is truly GISP and not education professionals
 - Based on 45 knowledge skill areas
- 2-3 years into career is the best time to take exam. You must complete all steps in 6 years
- Exam blueprint on GISP website
- Exam is administered by PSI, but switching to Pearson Vue
- 100 questions, but answer 140 questions
- 3rd party workshops (TeachMeGIS, URISA), GISCI unofficial exam prep doc
- Review of certification vs. license
- Encourages employers to hire GIS people
- Future direction of GISP
 - Expand internationally – received many complaints that the GISP more US centric
 - Pre GISP exam for newly graduated students and new designation for retired GISP's

2:00 Utility Events Dashboard (Joe Lasch)

- Live demo of Department of Public Service (DPS) new application (ued.dps.ny.gov)
- App that's used by DPS to track electrical outages for utility companies – NYSEG, National Grid, Con Edison
- Companies wanted the UED to mirror the maps they are giving to the public
- Every house outage is a submission
- App works with live data
- Analytics – Tableau dashboards, alerts powered by Everbridge
- Series of map layers – a variety of incidents that can be viewed (general, critical, or fatal)
 - Outage by municipality
 - Outage by type, by utility company etc.
- Weather related data – UAlbany Mesonet
 - The data is retrieved by using Python to access the API and then the data is pulled in
- The date updated can be found in many spots in the app to see when the data is submitted
- Custom alerts can be created

Discussion:

Ana – Who has access? This would be useful for emergency services. Could be shared with the PSAPS?

Joe – internal to DPS, so DPS does not receive outage questions. DHSES can view parts of the map outages by counties.
